LIFEGUARDS NEEDED FOR 2021 SEASON

If you know of anyone interested in lifeguarding, they must be 16 years or older and hold an American Red Cross lifeguard card.



POOL PARTIES

To host a pool party, you must be a Lansbrook resident who is current on your dues. Parties increasing the occupant load greater than 25 will require a Lifeguard at \$15.00/hour per lifeguard.

During pool hours:

- \$25 clean up deposit
- \$40 rental fee

Morning/Evening Parties:

- \$25 clean up deposit
- \$40 rental fee
- \$15/hour per lifeguard
- Only one evening party per day will be scheduled.
- All evening parties end at 11 pm.

UPDATED COVENANTS: FAQS

"What is the timing on this project?"

- All residents will receive an amendment and ballot in April.
- Informational meetings will be held in April.
- Voting will occur in May.

"Why do we need to amend the covenants?"

- Update/modernize language and clauses
- Consolidate various sets

"How can I make comments on the proposed amended covenants?"

"What if I want to vote 'Yes'?"

To vote yes for the amendment, you may sign a ballot before a notary and return your ballot to the Association or its attorney Matthew L. Winton before May 17.

Or, you may attend the voting meeting on May 18 at 7 pm and vote in person.

"What if I want to vote 'No'?"

To vote no, you need not do anything. Only those voting in person or by written ballot will be counted "yes" for the amendment.

Anyone not voting, or not present at the voting meeting, will automatically be counted as a "no" vote.
